# Your responsibilities

The doctoral student will be preparing a PhD thesis on the role of events in shaping personal timelines in ego-documents from the end of the Middle Ages and the beginning of early modern times. This work will be carried out under the joint supervision of Professor Thalia Brero (University of Neuchâtel) and Aude-Marie Certin (University of Haute-Alsace).

The fifteenth and sixteenth centuries are a particularly fertile period for understanding people's intimate relationship with time. As the written word and its media became more accessible, dates began to be noted more often, for example in family record books. This thesis will attempt to define what the men and women of this era considered to be an event, and how these emanations of the present were transformed into milestones in their conception of time.

In autobiographical texts, memoirs and 'family books', personal events (births, weddings, deaths, the acquiring of property, etc.) are interwoven with memories of public events (coronations, battles, etc.) or events affecting entire communities (natural disasters, epidemics, etc.) to form a timeline specific to each individual. How do these micro- and macro-events tell a life story, together? Are they ordered to provide a gradation to the measurement of time? In what way are these significant instants told and immortalised in words and memories, which become temporal markers?

In order to determine this, the doctoral student will draw on a corpus of ego-documents (French, German, Dutch, or English) compiled from existing databases and her or his own research.

### General information about the project

Funded by the Swiss National Science Foundation, the Sinergia project Capturing the Present in Northwestern Europe (1348–1648). A Cultural History of Present before the Age of Presentism examines how the concept of 'present' was perceived and experienced in Northwestern Europe from the Middle Ages to early modernity. This geographical area, which includes the Netherlands, the western German Empire, northern France, and southern



England, underwent significant changes during this period in politics, economics, religion, and the arts. Characterised by the coexistence of various political systems and languages, significant urban development, and rapidly evolving living conditions, this region offers a unique historical context that differs from the traditional depiction of the Renaissance.

The Capturing the Present project brings together around fifteen researchers from the universities of Neuchâtel, Lausanne, and Lille, including 6 PhD candidates and 3 postdoctoral researchers. The team is supported by an international network of experts in history, art and literary history, linguistics, media studies, anthropology, and political science. Its aim is to demonstrate how discourses and images shaped the perceptions that men and women of that time had of their own era; how contemporary events were represented and interpreted; and how new ideas, as well as environmental, political, and societal changes, were perceived.

## Your profile

Master's degree in history, specialising in medieval history or early modern history (or equivalent qualification).

Excellent command of French or English, as the thesis will be written in one of these two languages.

Ability to read Middle French and Middle High German. Fluency in Dutch would be a plus. Ability to work as part of a team in an international and interdisciplinary environment.
